- i) Dŵr yn cronni ger Fferm Temple Bar/*Water amassing near Temple Bar*

The County Council has confirmed that they are in the process of taking steps to remedy this amassing of water and fully aware of its extent.

8 Gohebiaeth/Correspondence

- i) Eisteddfod Genedlaethol 2026/*National Eisteddfod 2026*

Teifi referred to the poor state of the area's roads during recent years. He proposed that we contact Ceredigion's Clic service in order to raise their awareness of our concerns. It was unanimously agreed.
