a) Caiacau yn Tresaith/Kayaks in Tresaith

Nid oeddent yn gwybod pwy oedd yn perchen y rhai oedd yn dal ynghlwm i'r ffens ger mynediad y traeth/in reply to the Council's email to Tresaith Boating Club asking whether the owners of the Kayaks stored them with the Club over the winter; it was only members of the Club that stored the Kayaks on a first come basis. They did not know who owned the kayaks that were attached to the fence near the beach entrance.

WalwynParry-Jones had been down to see whether a rubbish bin had been placed outside the shop, there was a rubbish bin there with a Ceredigion CC clear rubbish bag inserted within the bin therefore it was presumed that Ceredigion CC had done this as the van is around approximately twice a week. Cllr. Jones reported that everything looked clean and tidy around the entrance to the beach

Ar gais Banc Lloyds, llythyr wedi mynd wrth Julian Harries, Cyfrifydd, DMB Davies Aberteifi yn cadarnhau bod Cyngor Cymuned Penbryn yn bodoli ac yn cwrdd yn Neuadd Goffa Penbryn.

Wedi ffono pob dydd o'r 27/3/23 a dwy waith ambell I ddiwrnod a'r ateb pob tro oedd 48 awr arall, hyd dydd llun 3/4/23 pan gafodd Lloyds wybod mae dyna'r ateb oedd y Cyng. Melva Phillips wedi ei dderbyn I pob galwad pan yn ffono I ofin statws y Cais. Ar ol hir drafod, awgrymodd y Banc I drosglwyddo'r galwad i'r adran gwynion er mwyn iddynt edrych miwn i'r cais yn fanwl. Fe ddywedodd yr adran gwynion y byddain bosib I 4 diwrnod fynd heibio cin y medrith ddod nol a gwybodaeth. Cyng. Phillips ffono heddi ddwetha a dal I aros I glywed wrthynt. Y Cais hwn wedi dachre ar y 24/1/23

The account remains un-opened. Cllr Melva Phillips has rung Lloyds Bank on numerous times. On the request of Lloyds Bank the Clerk spoke to Julian Harries, Accountant, DMB Davies, Cardigan to ask whether he could send on company letterhead paper that he acted on behalf of the Penbryn Community Council and they held their monthly meetings at Penbryn Memorial Hall, Sarnau. This was emailed on 24/3/23 to Lloyds.

Cllr. Melva Phillips rang them every day since the 27/3/23 and twice on some days, and received the same response every day saying another 48 hours, but on Monday 3/4/23 Cllr Phillips told Lloyds that this was the continuous message we received every time we contacted them. Following a long discussion, the Bank suggested to Cllr. Phillips that she transfers to the Complaints Dept. for the reason that the council had a strong reason to lodge a complaint. Cllr. Phillips was told by the Complaints Dept that it could take up to 4 days to come back with an update on the complaint made. Cllr Phillips rang again on 4/4/23 but no change to the Account Status at the moment. The application was first made on 24/1/23

On the 29/3/23, Lloyds Bank confirmed that the account would be open at the latest Thursday afternoon 30/3/23. Therefore, the Clerk instructed CCC on the 29/3/23 to release the money as the account would be open on the Thursday and the CCC money would hit the account on Friday 31/3/23 being the final day of the financial year for the County & Community Council. But the account did not open by close of business on the Friday. The Clerk contacted Marie McGranahan first thing on the Monday morning 3/4/23 and was told that the money had bounced back to Ceredigion County Council's bank account and would remain there until the Community Council instructed Ceredigion that the bank account was open

After a discussion the Chairman Cllr Caerwyn Owen offered to pay the premium on behalf of the Council using his own personal cheque and be refunded as soon as the new Bank Account is opened.

All members accepted this offer and thanked Cllr. Owen for his offer.
