2 Materion Personol/Personal Matters

Estynnwyd cydymdeimlad â Teifi a'r teulu ar golli chwaer yn ddiweddar.

Members conveyed their condolences to Teifi and the family on losing a sister recently.

3 Cofnodion Cyfarfod Misol/Monthly Meeting Minutes – 4/6/24.

Cynigiwyd eu bod yn gywir gan Barri a'i eilio gan Teifi.

4 Materion yn Codi/Matters Arising

i) Terfyn Cyflymder 20 mya/20 mph Speed Limit

Nododd y Clerc ei fod wedi derbyn gohebiaeth gan Weinidog Trafnidiaeth Llywodraeth Cymru yn egluro natur yr adolygiad i'r polisi uchod. Anogwyd y Cyngorau Cymuned i gysylltu â'r Cyngor Sir er mwyn hysbysu'r awdordodau o'n dymuniadau. Cytunwyd yn unfrydol i anfon yr un argymhellion a gyflwynwyd i adroddiad Elin Jones.

The clerk noted that he had received correspondence from the Welsh Government's Transport Minister explaining the nature of the review to the above mentioned policy. Community Councils were encouraged to inform the County Council of their recommendations. It was unanimously agreed to resubmit the suggestions proposed in Elin Jones' report.

ii) Cyfarfod Zoom Gwyn/Gwyn's Zoom Meeting

Mynychodd Gwyn gyfarfod yng nghwmni'r Asiantaeth Priffyrdd. Yn ystod y cyfarfod cododd bryderon y Cyngor hwn ynghylch diogelwch yr A487. O safbwynt llinellau gwyn dwbwl, awgrymwyd y byddai gwell gobaith pe bawn yn ennill cefnogaeth yr Heddlu. Cytunwyd yn unfrydol y byddai'r Clerc yn gohebu â Heddlu Dyfed Powys er mwyn canfod sawl damwain neu fân ddigwyddiad sydd wedi bod yma yn ddiweddar. Ynghylch diogelwch croesffordd Gogerddan awgrymodd Gwyn mai mater o ddyfal donc fydd hi er mwyn codi'r ymwybyddiaeth.

Gwyn attended a meeting with the Highways Agency. During the meeting he raised concerns regarding safety along the A487. As regards double white lines, it was suggested we attain Police support. Unanimously agreed that the Clerk corresponds with Dyfed Powys Police in order to ascertain the number of incidents that have occurred here recently. As regards the safety of Gogerddan Junction, it was suggested constant campaigning was needed to raise awareness.

iii) Meinciau Tresaith/Tresaith Benches

Diolchwyd i Melva am fynd ati i ddewis y fainc addas ar gyfer y safle. Awgrymodd Walwyn fod eisiau mesur sail y meinciau yn unigol er mwyn sicrhau bod y fainc addas yn cael ei dewis. Ar y mater hwn cynigiodd fynd i'w mesur ar ran y Cyngor ac yna cysylltu â'r Clerc er mwyn cadarnhau addasrwydd y meinciau.

Members thanked Melva for her efforts to select the appropriate benches for this location. Walwyn suggested that we measure the foundation of these benches and secure the most suitable bench. He offered to measure the foundations and confer with the Clerk on the matter of purchasing the appropriate bench.

- i) Mynwent Tanygroes/Tanygroes Cemetery
