Dywedodd y Clerc ei fod wedi gohebu â'r Asiantaeth Ffyrdd yng Nghonwy er mwyn mynegi pryderon parhaol yr aelodau am nifer y damweiniau sydd yn digwydd ar hyd yr heol yn y plwyf hwn.

The Clerk confirmed that he had corresponded with the Highways Agency at Conwy in order to express the members' concerns regarding road safety on the A487 within our parish.

This would be of great assistance in enabling us to come to a final decision on this matter. The members discussed the issues thoroughly, and agreed to make further enquiries on the following issues –*
- UNFORESEEABLE COSTS – vandalism, damage, effects of storm and elements on building/water supply/ burst pipes.*
- INSURANCE COSTS – Are there substantial additional costs?*
- THE BLUE FLAG – What is essential in order to maintain status?*
- The Clerk agreed to prepare further questions to be forwarded to the County Council.*
