5 Materion yn Codi/Matters Arising

i) Toiledau Tresaith/*Tresaith Toilets*

Yn dilyn penderfyniad yr aelodau i wrthod derbyn cyfrifoldeb am gynnal a chadw toiledau Tresaith yn y cyfarfod diwethaf, gohebodd y Clerc â'r Cyngor Sir er mwyn ei hysbysu o'n penderfyniad. Mynegwyd hefyd ein parodrwydd i wneud cyfraniad ariannol pellach tuag at gost eu cynnal dros y flwyddyn a ddaw.

Following the members' decision to refuse the option of maintaining the public toilets at Tresaith, the Clerk corresponded with the County Council to inform them of our decision. He also noted our willingness to make a further financial contribution towards the maintenance cost over the coming year.

ii) Cais Cynllunio Pencwm/*Pencwm Planning Application*

Gohebodd y Clerc â'r Adran Gynllunio er mwyn mynegi anfodlonrwydd a gwrthwynebiad yr aelodau i'r cais cynllunio uchod a gyflwynwyd y mis diwethaf. Nodwyd arwyddocad hanesyddol a phensaerniol yr adeilad.

The Clerk corresponded with the Planning Department in order to express our opposition to the above mentioned planning application submitted last month. The property's historical and architectural features were noted.

- iii) *Draenau Sarnau Park/Sarnau Park Drainage*
Cafwyd cadarnhad oddi wrth y Cyngor Sir nad oedd rhwydwaith draenau ger Sarnau Park yn gweithio'n effeithlon, a bod rhaid gwneud gwaith atgyweiriol arnynt. Dyma beth sydd wedi achosi i'r dŵr gronni yno yn ddiweddar.
Confirmation was received from Ceredigion Council that the drainage network near Sarnau Park isn't functioning correctly. Work will commence on restoring the drainage in the future. This is what has caused water to accumulate there recently.

Derbyniwyd cais oddi wrth drefnwyr Eisteddfod Gadeiriol Rhydlewis.
Datgelodd Elen fudd personol ynghylch y mater hwn.
Cytunodd yr aelodau yn unfrydol i gyfrannu £150 tuag at gynnal yr Eisteddfod.
An application was received from the organisers of Eisteddfod Rhydlewis. Elen declared a personal interest in this matter. The members unanimously agreed to contribute £150 towards the Eisteddfod.
- iv) *Cais am fatri i ddeffibrilwr/Application for Defibrillator Battery*
Derbyniwyd cais oddi wrth Gaffi Emlyn, Tanygroes am fatri newydd i'r deffibrilwr y tu allan i'r Caffi. Cytunodd yr aelodau i brynu'r batri ar eu rhan gyda Delfryn yn cynnig a Teifi yn eilio.

A request was received from Caffi Emlyn, Tanygroes for a replacement battery to the defibrillator outside the Caffi. The members unanimously agreed to the request with Delfryn proposing and Teifi seconding the motion.

v) Gosod Praesept 2026/27/*Setting Precept 2026/27*

Cafwyd trafodaeth helaeth ynghylch ein blaenoriaethau ar gyfer y flwyddyn a ddaw. Yn dilyn y penderfyniad a wnaed ynghylch tai bach Tresaith yn ddiweddar, ynghyd ag ystyriaethau eraill, cytunwyd yn unfrydol i rewi cyfanswm y Praesept a'i gadw ar gyfanswm eleni sef £15000.00.

The members had a comprehensive debate about our future priorities next year. Following our decision regarding the toilet provision at Tresaith, as well as other considerations, it was unanimously agreed to keep the amount at the present level, namely, £15000.00.

Delfryn referred to a continuously flickering street light at Sarnau or at worse not even working at all. Its number is 139. He has attempted to contact the Highway Agency but has not received a reply. The Clerk agreed to correspond on behalf of the Community Council.
