5 Materion yn Codi/Matters Arising

i) Batri Deffibrilydd Tanygroes/*Tanygroes Defibrillator Battery*

Adroddodd y Clerc fod batri newydd a nodwyd uchod wedi'i brynu a'i osod yng Nghaffi Emlyn, Tanygroes. Yn yr un modd, derbyniwyd cais am gymorth tebyg ar gyfer ffram newydd ar gyfer deffibrilydd ym Maes Carafanau Maesglas. Cytunwyd yn unfrydol i gyfrannu £300 tuag at y gost gyda Delfryn yn cynnig a Teifi yn eilio.

The Clerk reported that the above mentioned battery has been ordered and delivered to Caffi Emlyn, Tanygroes. In addition, a similar request was received for a new defibrillator frame from Maesglas Caravan Park. It was agreed unanimously to contribute £300 towards the cost with Delfryn motioning and Teifi seconding.

ii) Golau Stryd Sarnau/*Sarnau Street Lighting*

Nododd Delfryn fod y golau diffygiol ym mhentref Sarnau wedi'i atgyweirio ar Ionawr 13eg.

Delfryn confirmed that the faulty street light at Sarnau has been repaired on January 13th.

iii) Cyfarfod Diogelwch yr A487/*A487 Safety Meeting*

Adroddodd Gwyn ei fod yn bresennol yn ystod y cyfarfod hwn ym Mhenmorfa, Aberaeron. Cadarnhaodd fod y Swyddogion oedd yn bresennol yn cydymdeimlo'n fawr â'r pwyntiau a nodwyd, megis yr angen am olau stryd yn Nhanygroes a'r angen am linellau gwyn dwbwl ar hyd yr heol ym mhlwyf Penbryn. Bydd y swyddogion yn ystyried y pwyntiau hyn y neu cynlluniau tua'r dyfodol.

Gwyn reported that he was present during this meeting at Penmorfa, Aberaeron. He confirmed that the officials present sympathised with the issues raised, namely the need for street lighting at Tanygroes and the need for double white lines along the A487 within our community. The officials will consider these points in their future decisions.

- i) Glanhau Cwteri/*Drainage Maintenance*
Mynegodd yr aelodau awydd i gynnal a chadw heolydd y plwyf yn fwy cyson dros y gaeaf yn dilyn yr eira a'r glaw diweddaraf. Cytunodd y Clerc i gysylltu â gwasanaeth CLIC y Cyngor Sir.
Members expressed a desire to maintain roads within the parish on a more regular basis following the recent snow and rain. The Clerk agreed to contact CLIC at the County Council.
- ii) Y Cardi Bach
Mynegodd yr aelodau hefyd eu hawydd i weld y gwasanaeth bws hwn yn cael ei adfer. Teimlid bod y gyndogaeth ar ei cholled heb y ddolen gyswllt hon. Cytunodd y Clerc i gysylltu â'r Cyngor Sir ac Elin Jones.
Members also expressed a desire to restore this bus service. It was felt that the community was deprived of a vital transport link. The Clerk agreed to contact the County Council and Elin Jones.
- iii) Hysbysfwrdd Neuadd Goffa Penbryn/*Penbryn Memorial Hall Noticeboard*
Nododd Delfryn ei fod wedi ceisio atgyweirio'r clo ar yr hysbysfwrdd uchod. Codwyd y cwestiwn a oes angen cloeon newydd ar ein hysbysfyrddau yn gyffredinol? Cytunodd Delfryn i wneud ymholiadau.
Delfryn stated that he had attempted to repair the lock on the above mentioned noticeboard. The question was raised whether new locks were needed on our noticeboards in general? Delfryn agreed to make further enquiries.
- iv) Cyflwr Llwybr yr Arfordir/*Condition of Coastal Path*
Testun pryder arall i'r aelodau oedd cyflwr y llwybr mewn manau rhwng Tresaith a Phenbryn. Cytunodd y Clerc i gysylltu â Llywodraeth Cymru.
Another concern was the condition of certain sections of the coastal path between Tresaith and Penbryn. The Clerk agreed to correspond with the Welsh Government.
