- i) Cyflwr Meinciau Tresaith/*Condition of Tresaith Benches*  
Tynnodd Walwyn nifer o luniau yn nodi cyflwr y meinciau yn Nhresaith. Daeth yn amlwg fod nifer ohonynt mewn cyflwr lled dda gydag angen am ychydig bach o waith cynnal a chadw yn unig. Cynigiodd Walwyn y medrai wneud y gwaith hwn dim ond inni brynu ystyllau newydd i'w rhoi ar y meinciau. Cefnogwyd hyn gan Barri a'i eilio gan Gareth. Nodwyd hefyd fod y Fainc Goffa yn yr arosfan bysiau mewn cyflwr da yn bennaf am ei bod yn rhan o'r gysgodfan ac wedi'i phaentio yn ddiweddar.  
*Walwyn brought along numerous photographs highlighting the condition of Tresaith's benches. It became evident that many were in good condition with only the need for minor maintenance. Walwyn offered to undertake the work if the material were provided. This was supported by Barri and seconded by Gareth. The Memorial Bench by the bus shelter was in good condition mainly because it was an integral part of the shelter and recently painted.*
