- i) Neuadd Goffa Penbryn/*Penbryn Memorial Hall*
Mae Pwyllgor y Neuadd hon yn ystyried gwneud gwaith cynnal a chadw ar y Neuadd gan ofyn am barodrwydd y Cyngor hwn i gyfrannu'n ariannol tuag at y gwaith. O bosibl, gall olygu gosoda darparu WI-FI.
